Enforcing Ohio's smoking ban no money maker

Since enforcement of the statewide smoking ban began in May 2007, Steve Peters, manager of the River City Boat House, has seen a decrease in the number of people eating at the restaurant.

"About 20 percent of our population smokes, so if those people are isolated or prevented from partaking in their personal habits, they're less likely to stay and order more food and order another drink," Peters said.

The ban prohibits smoking in any public place or place of employment, and requires that these places post no-smoking signs and remove all ashtrays.

The restaurant, located on Virginia Street in Marietta, is one of several businesses in the county where a violation of the smoking ban has been reported to the state. It was not immediately apparent whether the June 2007 complaint was verified.

Data from the Ohio Department of Health shows the state has spent \$2.3 million to enforce the ban and about \$1.2 million in fines has been assessed. Some have questioned whether the results of the ban justify its costs.

Kathleen Meckstroth, Washington County health commissioner, isn't one of them.

"It would cost far more than that in the cost of health care, and that's the thing you have to weigh," she said. "It prevents people from being exposed to secondhand smoke that could lead to other health problems."

Beverly resident Kimberly Lewis, 49, thinks a smoking ban is necessary, but would rather see the money should be spent to reinstate the Early Learning Initiative (ELI) program for underprivileged children.

"People need to realize, it (smoking) hurts everyone's health and it needs to be kept out of restaurants," Lewis said. "If they want to enforce it, they need to stop selling it all together, or make it such an astronomical price that people stop doing it."

Marietta resident Nicole Huffman, 32, would also like to see the money being spent elsewhere.

"As a mother of three children and one on the way, I realize health issues are a major factor," she said. "But I would definitely like to see that money invested in our education system."

The \$2.3 million spent by the state so far "funds positions, funds the activities of the investigators to check on reports of violations, and various other administrative costs," said Sara Morman, Public Information Officer with the department.

In total, about 200 complaints have been filed with the state for businesses in the county, some of which are repeat violators of the law.

Violations within the City of Marietta are only handled by the state health department, while violations elsewhere in Washington County are investigated by the county health department.

But first, the violation has to be reported to the Ohio Department of Health's toll free hotline, 866-559-OHIO (6446).

"Those reports are sent to us and we send a sanitarian to investigate to see if there is smoking taking place on the premises," Meckstroth said.

"We issue a warning letter, and the owner has so many days to respond to the warning letter, and if we receive another report of smoking, there is a series of fines that start at \$100 and go up to \$2,000," she added.
